## DOMESTIC VIOLENCE

GOAL: All residents in Calhoun County will be free from domestic violence

**RATIONALE FOR CHOOSING INDICATOR:** Domestic Violence affects individuals in every community, regardless of age, economic status, race, religion or educational background. It can result in physical injury, psychological trauma and sometimes death. Domestic violence is a pattern of power and control that can impact all areas of a victim's life. While the physical injury that results from this crime is tragic, it is only a part of what the victim experiences. Often, the assailant exercises abuse and control in financial matters, social situations and parenting decisions. This results in a victim who may want to leave but has been isolated, has no access to financial resources, and is threatened with harm to her children.
